**STIPULATED AGREEMENT
AND ORDER**

The Oregon Veterinary Medical Examining Board (OVMEB) is the state agency responsible for regulating, licensing, and disciplining veterinarians in the State of Oregon. Daniel Koller, *D. V.M.* (Licensee) is licensed by the OVMEB to practice veterinary medicine in the State of Oregon.

1. On February 11, 2002, Licensee sent the OVMEB a letter requesting guidance relating to disciplinary actions proposed in California, where Licensee was licensed to practice veterinary medicine.

2. At its April 2002 meeting the OVMEB reviewed Licensee's letter and directed Licensee to undergo an assessment by a substance issues specialist. Licensee complied.

3. On June 3, 2002, the OVMEB received a report from Dr. Walton E. Byrd MD, which evaluated Licensee and recommended continued licensure with participation in appropriate therapies.

4. On November 19, 2004, the California Medical Board adopted a Stipulated Settlement and Disciplinary Order, which is incorporated herein and becomes a part of this Stipulated Agreement with Licensee that conditionally lifted the suspension of Licensee's California veterinary license.

In the interest of a prompt and speedy settlement of the above-captioned

1 matter, consistent with the public interest, statutory requirements and the
2 responsibilities of the OVMEB, and pursuant to ORS 183.415(5), Licensee and the
3 OVMEB consent, stipulate and agree to the following.

5 **STIPULATED AGREEMENT**

6 Licensee agrees and stipulates to the actions described above, and
7 That the OVMEB has grounds for discipline against him under ORS 686.120
8 686.130(12).

9 Licensee agrees that any violation of the California Stipulated
10 Settlement and Disciplinary Order may result in additional discipline in
11 Oregon.

12 Licensee understands that all investigative materials prepared or
13 received by the OVMEB concerning this violation and all notice and pleadings
14 relating thereto may be retained in the Board's file concerning this
15 matter.

16 Licensee, aware of his right to a hearing with assistance of counsel,
17 the right of judicial review of the OVMEB's decision to contest the charges
18 against him, hereby freely and voluntarily waives those rights. In lieu of
19 a formal hearing in this matter, Licensee stipulates to the preceding
20 conditions and the following Order.

21 **ORDER**

22 Licensee agrees to comply fully with the terms and conditions of the
23 Stipulated Settlement and Disciplinary Order adopted by the California
24 Veterinary Medical Board on November 19, 2004 and the Oregon Veterinary
25 Practice Act.

1 I HAVE READ AND UNDERSTAND ALL OF THE ABOVE CONSENT AGREEMENT AND FINAL
2 ORDER AND FULLY CONSENT AND AGREE TO ALL OF ITS TERMS.
